The conference is designed by the PAGS-WD planning committee, which consists of a consortium of your colleagues, including those from the community, academic and payor sectors.

- Geriatrics Teacher of the Year Award Initiated in 2016, this award recognizes outstanding teachers for their dedication and commitment to geriatric education and who have made significant contributions to the education and training of learners in Geriatrics. The call for nominations will begin Oct. 1, with the awards presentation to take place during the 29th Annual Clinical Update, scheduled for April 8-10, 2021.
- David C. Martin Award Named after Pittsburgh's first full-time geriatrician, this award provides financial support for medical students and other trainees who have had scholarly work accepted for presentation at the national meeting of the American Geriatrics Society. A student may receive up to \$1,500 for travel, registration, and hotel costs. Since its inception, the Society has granted more than \$80,000 to awardees.
- Resident and fellow interest remains strong, with recruitment of nine new resident and fellow members this year. This brings the total number of resident and fellow members to 33. The Society waives membership dues for the length of training. We hope this initiative will be a pipeline to bring young physicians into our organization.

David A. Nace, MD, MPH, CMD, Named to White House Coronavirus Commission

David A. Nace, MD, MPH, CMD, President of AMDA, The Society for Post-Acute and Long-Term Care Medicine in Pennsylvania, Chief Medical Officer of UPMC Senior Communities in Pittsburgh and a member of the Board of Directors of the Pennsylvania Geriatrics Society - Western

Division, was selected among the top leaders in the long-term care industry to serve on the newly formed federal nursing home task force.

In this role, Dr. Nace will review nursing homes' response to the COVID-19 pandemic and recommend new regulations and procedures for future emergency situations.

Task force members will work to formulate best practices to protect nursing home residents on three fronts:

- Putting nursing home residents first by ensuring they are protected from COVID-19 and improving the responsiveness of care delivery to meet the needs of all residents to maximize quality of life for residents
- Strengthening regulations to enable rapid and effective identification and mitigation of COVID-19 transmission in nursing homes
- Enhancing federal and state enforcement strategies to improve compliance with infection control policies in response to COVID-19

The White House Commission met regularly this summer and planned to provide a report the first week of September 2020.

AGS Names 2020 Clinician of the Year

The American Geriatrics Society (AGS) named James Lin, DO, MS, MHSA, President of the Lake Erie College of Osteopathic Medicine (LECOM) Institute for Successful Aging, its 2020 Clinician of the Year. Dr. Lin will be honored at the AGS 2021 Annual Scientific Meeting, May 13-15, 2021 in Chicago, due to the cancellation of the AGS 2020 Annual Scientific Meeting based on the COVID-19 pandemic.

According to AGS Board Chair Sunny Linnebur, PharmD, FCCP, FASCP, BCPS, BCGP, "Dr. Lin's drive to enhance geriatrics stems from something deeply personal: Witnessing the marginalization of older adults while caring for his own father. Wanting better - and knowing it was possible - launched more than just a career as an expert clinician; it launched a commitment to modeling the way for others, which is well worth this high recognition."



LECOM leadership, aware of Dr. Lin's vision for education and improved geriatric care, empowered him to develop a program that could not only accelerate better care but serve as a guide for others in the field. Dr. Lin not only developed a robust geriatric service at LECOM but also became one of its principal champions by providing care to hundreds of older adults while translating that standard of care to training for future health professionals.

Dr. Lin became of member of AGS in 2007, after earning his medical degree from LECOM in 2002. Dr. Lin completed his geriatric fellowship at the University of Medicine and Dentistry New Jersey before joining LECOM as Director of its Institute for Successful Aging. He is board certified in internal medicine, geriatric medicine and hospice and palliative medicine.

State Launches Regional Response Health Collaboration Programs (RRHCP)

Will Provide Covid-19 Assistance to Long-Term Care Facilities

UPMC & AHN Partner with JHF and Local Health Systems, Creating the Western PA RRHCP

of 1,200 personal care homes and assisted ore than 45,000 Pennsylvanians live in excess living residences, while more than 80,000 residents live in 693 skilled nursing facilities throughout the Commonwealth. These residents often are some of the most vulnerable and susceptible to COVID-19. Based on this information, the Educational Support and Clinical Coaching Program (ESCCP) was rapidly launched in Pennsylvania to address long-term care facilities' needs in April 2020. A partnership between Nancy Zionts, COO and Chief Program Officer at the Jewish Healthcare Foundation (JHF), the Pennsylvania Department of Human Services, and seven Pennsylvania health systems, the ESCCP has provided long-term care staff with training and support to advance care for seniors across the state. Since the program's start, JHF has hosted 15 webinars and engaged more than 2,000 participants in discussions about COVID-19 response, preparation and planning for the new normal that congregate living facilities are facing.

Recognizing the need and success of programs initiated by ESCCP, former PA Speaker of the House, Michael Turzai, worked with David A. Nace, MD, MPH, President of AMDA, The Society for Post-Acute and Long-Term Care Medicine and Chief Medical Officer of UPMC Senior Communities in Pittsburgh (an active member of the PA Geriatrics Society - Western Division), who collaborated with UPMC and Allegheny Health Network (AHN) to create a bill to expand the

program. House Bill 2510 was passed by both PA Houses of Congress and signed into law by Gov. Tom Wolf. The bill created the Regional Response Health Collaboration Programs (RRHCP), which are designed to assist the state in providing clinical, operational, and administrative support to protect residents in long-term care facilities from COVID-19. The six RRHCP programs will help facilities implement best practices in infection control, conduct onsite COVID-19 testing, implement contact tracing programs in facilities, and provide advanced clinical care consultation. The RRHCPs also may assist facilities with obtaining emergency staffing augmentation, PPE appropriation, and identification of alternative care sites when needed.

Serving southwest and portions of northwest Pennsylvania, the Western PA RRHCP program is a cooperative partnership led by UPMC Senior Services and AHN. The Western PA RRHCP works closely with JHF and the Healthcare Council of Western Pennsylvania, in addition to several local health systems including Excela Health, St. Clair Hospital and Penn Highlands.

According to Emily Jaffe, MD, Vice President and Executive Medical Director of HM Home and Community Services and post-acute Medical Director at AHN, "To effectively meet the health needs of all members of western Pennsylvania communities during this unprecedented time, we are extremely pleased to be part of this collaborative which brings together the region's leading healthcare resources for the benefit of seniors and others who are at most risk for COVID-19."
